WHEREAS, on January 27, 2015, this Court ordered that Defendant Robert M. Cook shall cease and desist delivery of water for human consumption at Golf Mobile City, a mobile home or manufactured dwelling park located at 3375 SW 18<sup>th</sup> Avenue, Ontario, Oregon (the "subject property") by March 16, 2015, and that Defendant report to the Court any change in the ownership status of Golf Mobile City.

WHEREAS, pursuant to the Statutory Warranty Deed ("Deed") and Mortgage and ("Mortgage"), fully executed on January 29, 2015, Robert M. Cook and Linda N. Cook, husband and wife, and Marcus Divinity International, collectively Grantor, conveyed and warranted to Prico Holdings, LLC the subject property. Said Deed was recorded as Document 2015-0353 and said Mortgage was recorded as Document 2015-0354 on February 2, 2015 in the official records of Malheur County, Oregon. *Attached as Exhibits A and B respectively.*

Pursuant to the stipulation of the parties, the Court enters Supplemental Judgment as follows:

1. Should Robert M. Cook and/or any of his representatives at any future date come into possession of the subject property located at 3375 SW 18<sup>th</sup> Avenue, Ontario, Oregon, he

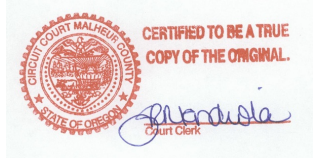
1 may not deliver water at the subject property without the prior approval of the Oregon Health


