SETTLEMENT AGREEMENT

The Oregon Health Authority, Public Health Division, Center for Health Protection, Drinking Water Services (Authority) issued a Notice of Intent to Impose Civil Penalty on October 15, 2015 assessing a \$3,000 civil penalty against Henrietta Knott for violations of the Oregon Drinking Water Quality Act (ORS 448.115 to ORS 448.290) and Oregon Administrative Rules related to the operation of the Bolder City Water System. On October 28, 2015 the Authority received a request for a hearing from Henrietta Knott.

The Authority and Henrietta Knott agree to resolve the matter of the \$3,000 civil penalty by stipulating as follows:

- Agreement Article No. 1: Henrietta Knott agrees to pay a civil penalty of \$300 to the Authority within 10 days of signing this agreement.
- Agreement Article No. 2: The Authority agrees to hold in abeyance the remaining civil penalty of \$2,700 until the deadline agreed upon for completion of Agreement Article 4 as specified herein.

- Agreement Article No. 3: Henrietta Knott agrees to consult with the Authority on or before March 1, 2016 and specifically identify how the finished water storage facilities serving the Bolder City Water System will be improved to meet all applicable construction standards in OAR 333-061-0050.
- Agreement Article No. 4: Henrietta Knott agrees to ensure that repair or construction of the finished water storage facilities serving the Bolder City Water System is completed such that facilities meet all applicable construction standards in OAR 333-061-0050.
 - Repairs or construction will be completed and facilities made available for inspection by a representative of the Authority or Jackson County Environmental Health Services on or before June 30, 2016.
- Agreement Article No. 5: Henrietta Knott waives all rights to a contested case hearing or any judicial review in this matter.
- Agreement Article No. 6: Henrietta Knott agrees to pay the remaining civil penalty of \$2,700 should she fail to meet the terms of Agreement Article 3 as specified herein. Payment of the civil penalty shall be due and payable within 10 days of a Notice of Violation of Settlement Agreement being issued.
- Agreement Article No. 7: The Authority agrees to permanently waive the remaining civil penalty of \$2,700 upon completion of the Agreement Article 4 as specified herein and if completed by the deadline agreed upon.

GENERAL PROVISIONS

This Agreement does not constitute a waiver, suspension or modification of the requirements of the Oregon Drinking Water Quality Act; ORS 448.115 to 448.285 and administrative rules OAR 333-061-0005 to 333-061-0290, which remain in full force and effect.

This Agreement does not relieve the Henrietta Knott of any responsibilities or liabilities established pursuant to any applicable federal, state, or local law or regulation.

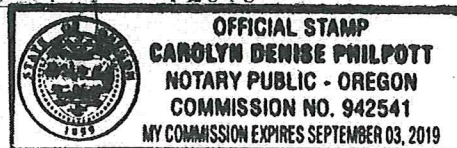
